



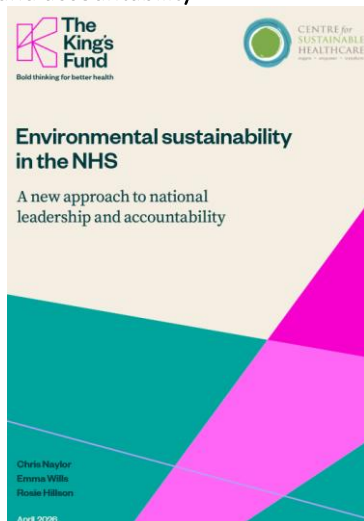

Department of Health & Social Care - Independent review into mental health conditions, ADHD and autism: interim report 	<p>This interim report sets out progress made on the independent review into mental health conditions, Attention Deficit Hyperactivity Disorder (ADHD) and autism, including the main findings from the evidence so far, including gaps and uncertainties. <p>NHSE - Neighbourhood health centre guidance for regions and integrated care boards</p>	<p>This guidance is both a statement of policy intent and a practical planning instruction for neighbourhood health centre (NHC) development in the current planning period. It sets out the strategic framework for how integrated care boards (ICBs) and NHS England regions, working with providers, should identify and develop NHC schemes to support neighbourhood health: the archetypes to consider, estate planning, pipeline development and funding routes. The guidance also instructs ICBs and NHS England regions on the planning work now required to develop a coherent pipeline of NHC schemes.</p> <p>https://www.england.nhs.uk/long-read/neighbourhood-health-centre-guidance-for-regions-and-integrated-care-boards/</p> <p>A specification has also been issued to support the planning and delivery of new-build neighbourhood health centres. <p>NHSE - The future of Freedom to Speak Up</p>	<p>Following the Dash review of patient safety across the health and care landscape, the government has agreed that the National Guardian's Office will close at the end of June 2026. From 1 July 2026, NHSE will deliver some activities previously undertaken by the National Guardian's Office, and healthcare organisations will take on greater responsibility and accountability for embedding effective Freedom to Speak Up arrangements. <p>NHSE - Annual assessment of Integrated Care Boards 2025/26: supporting guidance</p>	<p>NHSE has published guidance for the annual assessment process it will follow to assess ICB performance in the 2025/26 financial year. The assessment process will follow five sequential steps: using the NHS Oversight Framework's ICB contextual metrics data to understand each ICB's relative performance against the high-priority objectives for 2025/26; assessing performance and capability, using qualitative evidence and local insight; the reviewing of formal intervention, support and partnership feedback; agreeing and finalising the assessment conclusion; and finally summarising the individual regional reports and data in a single national summary report and publishing it on the NHSE website.</p> <p>https://www.england.nhs.uk/long-read/annual-assessment-of-integrated-care-boards-2025-26-supporting-guidance/</p> <p>For information</p>
<p>NHSE - Microsoft 365 Copilot information governance guidance</p>	<p>Microsoft 365 Copilot, including Copilot Chat (called "copilot" from this point) is a tool that uses Artificial Intelligence (AI). Health and care organisations may use copilot to help with day-to-day tasks. Copilot has both a free and a paid-for model. This guidance relates to the paid-for enterprise model which integrates with Microsoft 365 apps. <p>NHSE - Safeguarding accountability and assurance framework Fifth edition, 2026</p>	<p>Safeguarding children, young people and adults at risk in the NHS is a key priority. NHSE’s framework sets out the safeguarding roles and responsibilities of all individuals and organisations related to their statutory requirements, and appropriate accountabilities for the safeguarding of children, young people and adults at risk of harm or abuse.</p> <p>https://www.england.nhs.uk/long-read/safeguarding-children-young-people-and-adults-at-risk-in-the-nhs/</p> <p>For information</p>
<p>UK Covid-19 Inquiry - Module 4: vaccines and therapeutics</p> 	<p>This report examines how vaccines and therapeutics were developed, authorised and delivered across the four nations of the UK during the Covid-19 pandemic. It finds that decades of global research and preparation – including to develop mRNA vaccines and vaccine platform technologies – were fundamental to the UK’s Covid-19 vaccine response. 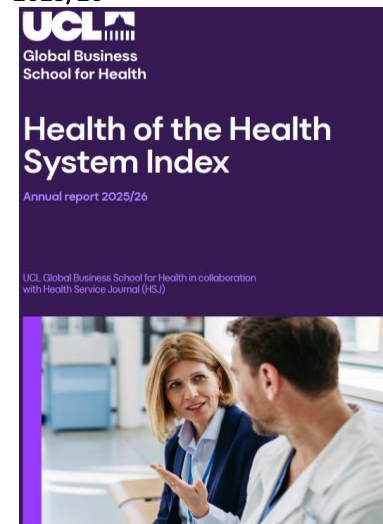

UCL Global Business School for Health - Health of the Health System Index: annual report 2025/26



This report introduces the “Health of the Health System” Index, developed by UCL Global Business School for Health in collaboration with the Health Service Journal. The Index offers a new perspective on NHS system health by combining structured quantitative indicators with the judgements of senior leaders across England. It focuses not only on outputs but on the organisational conditions – leadership, workforce, culture, integration, digital readiness, prevention, and financial alignment – that determine whether performance can be sustained and reform delivered over time.

Effective cyber security depends on collective responsibility across the organization, and all staff must understand their role. This briefing covers why cyber security matters, how to prevent cyber-attacks, and steps to take if an incident occurs. It is aimed primarily at NHS finance staff and non-executive directors in the UK.
